1. Application must be completed and returned at least thirty (30) days prior to the date of the scheduled event. S.C. Law Section 50-21-1010. Violation penalty - \$25.00 to \$200.00 or 30 days. S.C. Law Section 50-21-150.
2. Enclose a chart or scale drawing showing the boundaries of the event, various water course areas to be utilized by participants and spectators.
3. Enclose sponsor's proposed rules and regulations governing the event.
