1. Deadline for entry: At blast off morning of the tournament.

2. LAUNCH SEQUENCE WILL BE DETERMINED BY WHEN ENTRY FEE IS

RECEIVED.

3. Scoring: a) A Limit of 5 bass (largemouth, smallmouth, spotted, or cosa bass) may be weighed in. Any team bringing in more than a 5 bass limit to the scales will lose biggest fish to get down to the legal limit of 5 fish.

b) Minimum length will be twelve inches. Length will be measured on a flat board, mouth closed.

c) A short fish brought to the scales will result in a 1 pound penalty and loss of that fish.

d) Dead fish will be penalized four ounces. So please use ice and additives.

e) All culling must be done after the fifth fish is caught.

f) Late penalty is one pound per minute up to 15 min. Disqualification after 15 min. boat must be off plane in sight of the tournament check in boat. Which will be marked clearly.

5. ONLY artificial baits may be used. All bass must be caught alive in a legal sporting manner. No snagging, no trolling, only one rod must be used at a time. WHEN SIGHT FISHING, THE FISH MUST BE HOOKED INSIDE THE MOUTH TO KEEP!!!!

6. ANCHOR RULE: A team boat sitting with trolling motor up and anchor down, all other team boats must stay at least 50 yards away. No hole -sitting allowed. (meaning: another boat can not save a fishing hole for any team boat.)

7. All teams and their boats must stay in the water at all times during the tournament hours. Except for emergencies or at the direction of the tournament director.

8. In case of breakdowns, one team member may bring back fish in another teams boat.

9. Alcoholic beverages will not be allowed at tournament.

10. Good sportsmanship is expected from all teams at all times. Disorderly conduct will while result in disqualification.

11. All complaints or protest should be made to the tournament director 15 min. after conclusion of the weigh in.

12. ALL DECISIONS BY THE TOURNAMENT OFFICIALS ARE FINAL.

13. LIFE JACKETS MUST BE WORN, WORKING KILL SWITCH ATTACHED WHILE THE BOAT IS ON PLANE.

14. All teams are to abide by all state rules and regulations.

15. Boat captains must be 21 years of age, cannot be a local guide on that lake, CANNOT FISH NO EXCEPTIONS, Must have 300,000 liability insurance on boat according to B.A.S.S. rules

16. Cell phones are not permitted during the tournament except for emergencies.

17. A POLYGRAPH TEST COULD BE GIVEN AT THE CONCLUSION OF THE TOURNAMENT, FAILURE COULD RESULT IN DISQUALIFICATION!!!!!!

Waiver and Release

ALL PARTICIPANTS MUST EXECUTE THE FOLLOWING WAIVER AND RELEASE OF LIABILITY AND NAME AND LIKENESS RELEASE

As a condition of my being permitted to participate as a volunteer/competitor/ participant in the Abbeville open fishing tournament, the receipt and sufficiency of which is hereby acknowledged and intending to be legally bound, I agree to the following:

Name and Likeness Release

I hereby grant permission to B.A.S.S., LLC its parent companies, its subsidiaries and subsidiaries of its parent and their affiliates, their successors, licensees and assigns (the "Distributors") to utilize my appearance, performance, name, voice and likeness in connection with the Event itself

and any productions incorporating or based on the Event, in connection with publicity for the Event and future editions of the Event and in connection with the promotion of B.A.S.S., LLC and any tournaments or other events staged by B.A.S.S., LLC in any and all manner and media throughout the universe in perpetuity. I hereby waive any right that I may have to inspect or approve any finished product or any advertising copy that may be used in connection therewith or the use to which it is applied. I hereby warrant that I have the right to make this release and that my granting this release and the rights conveyed thereby will not infringe the rights of any third party.

#### Physical Condition

I am physically fit to participate as a volunteer/competitor in the Event, and have not been advised otherwise by a medical practitioner.

#### Equipment and Facilities Inspection

I agree that before I participate as a volunteer/competitor in the Event, I will inspect the related facilities and equipment. I will immediately advise the supervisor of the Event of any unsafe condition that I observe. I will refuse to participate in the Event until all unsafe conditions observed by me have been remedied.

#### Assumption of Risk

I understand that I, and each participant in the Event, will be engaging in activities that involve the risk of serious personal injury, illness, permanent disability, dismemberment and death, and that also involve the risk of severe economic and property loss and damage. I understand that these risks may result from the actions, negligence, fault, omission and failure to act of myself and others (including but not limited to participants, and the sponsors, organizers and volunteers of the Event) and from the rules of play, the challenges of the Event and the condition of any property, facilities or equipment used. I also understand that there may be risks involved which are not known to me or to the Distributors, organizers, and other volunteers, and may not be foreseen or reasonably foreseeable by any of them or us at this time or at the time of the Event.

I assume all of the foregoing risks including the risk of any negligence by other participants and the Distributors, organizers, or volunteers of the Event and their respective owners, directors, officers, employees or agents, and the risk of injury caused by the condition of any property, facilities or equipment used during the Event, and accept personal responsibility for any injury (including, but not limited to, personal injury, disability, dismemberment and death), illness, damage, loss, claim, liability or expense, of any kind or nature, that I or my property may suffer arising out of or in connection with the Event or my participation therein or attendance thereat.

#### Liability Release and Indemnity Agreement

I hereby release and forever discharge and agree to save and hold harmless B.A.S.S., LLC and its respective parents and their subsidiaries, subsidiaries of its parents and their affiliates, and its owners, officers, directors, employees and other volunteers associated or affiliated with the Event, the owners, lessors and lessees of the property, facilities and equipment used in connection with the Event, including without limitation the respective organizers, directors, officers, employees and agents of all of them, and the other participants in the Event (each such entity or individual being referred to as a "Released Party") of and from any and all injuries

(including personal injury, disability, dismemberment, and death), illness, losses, damages, claims, liabilities or expenses (including attorneys' fees) of any kind or nature (and whether accruing to me, my heirs or my personal representatives) that are caused or alleged to be caused in whole or in part by my action, negligence, fault, omission, failure to act, or by my breach or alleged breach of this Waiver and Release, or by

the condition of the property, facilities or equipment of any Released Party or that arise out of or in connection with the Event or my participation therein or attendance thereat.

#### Medical Treatment

In connection with any injury I may sustain or illness or other medical conditions I may experience during my participation in or attendance at the Event, I authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by the attending medical personnel if I am not able to act on my own behalf. I further authorize the attending medical personnel to execute on my behalf any permission forms, consents or other appropriate documents relating to medical attention and to act on my behalf if I am not able or immediately available to do so.
