**DNR YOUTH DEER HUNT – 2020**

**WATEREE RIVER HERITAGE PRESERVE WILDLIFE MANAGEMENT AREA**

The South Carolina Department of Natural Resources (DNR) will conduct one youth deer hunt at Wateree River Heritage Preserve Wildlife Management Area (WMA). The youth deer hunt is scheduled on November 7. There are eight slots available for the hunt. The Wateree River Heritage Preserve WMA is a 3,674-acre tract of land located seventeen miles east of Columbia on Highway 378 near the Eastover community. The property is situated on the Richland/Sumter County line, with all of the land area in Richland County. The property contains both upland pine and hardwood forest.

At the hunt, there will be a brief discussion of deer biology and the role of hunting in wildlife management along with detailed comments regarding sportsmanship and hunter ethics. There will be a thorough review of firearm safety. More detailed instructions and directions to the hunt sites will be provided to applicants who are selected based on a random drawing. This release constitutes a complete release, discharge, and waiver of any and all actions or causes of action against the State of South Carolina and its agency the South Carolina Department of Natural Resources, and its officers, agents, or employees and cooperating hosts, sponsors and landowners.

I understand and agree that this release applies to personal injury, property damage, or wrongful death, which I may suffer, even if caused by the acts or omissions of others.

I understand and agree that by signing this release, I am assuming full responsibility for any and all risk of death or personal injury or property damage suffered by me while participating in the draw hunt.

I understand that and agree that this release will be binding on me, my spouse, my heirs, my personal representatives, my assigns, my children and guardian ad litem for said children.

I understand and agree that by signing this release, I am to release, indemnify and hold the State of South Carolina and its agency the South Carolina Department of Natural Resources, and its officers, agents, or employees and cooperating hosts, sponsors and landowners harmless from any and all liability or costs, including attorney fees, associated with or arising from my participation in the draw hunt.
