- **1.** Preliminary draft to members of the task force. Changes should be submitted back to SCDNR.
- 2. Draft should then go to the agencies involved with the task force for review (up the chain of command with a deadline of 1 month).
- **3.** Return document to SCDNR with a letter of support stating that the agency is in favor of supporting the plan and will conform to the guidelines.
- **4.** Send document to national task force for informal review.
- 5. Send to Governor for signature and submit to national task force for final approval
